

# WESTPAC VISA DEBIT CARD PROMOTION

## Terms & conditions

The Westpac Visa Debit Card Promotion is available to individuals who open a new Westpac Transactional Account during the Promotion Period and successfully apply for a Westpac Visa Debit Card.

A free gift is available while stocks last and for a limited campaign period.

### Terms and Conditions

#### 1. Promotion Period

- The promotion commences on 10 August 2026 and ends on 07 September 2026 or when all promotional gifts have been exhausted, whichever occurs first.

#### 2. Eligibility

- The promotion is open to individuals aged 18 years and over.
- To be eligible, customers must:
  - Open a new Westpac Transactional Account; and
  - Successfully apply for and receive approval for a Westpac Visa Debit Card during the Promotion Period.
- Existing Westpac Visa Debit Card holders are not eligible to participate in this promotion.

#### 3. Offer

- Eligible customers will receive one (1) promotional gift upon successful opening of a Westpac Transactional Account and approval of a Westpac Visa Debit Card.
- Gifts are available on a first come, first served basis and are subject to availability.
- A customer will only be entitled to receive a gift if stock is available at the time all eligibility requirements have been satisfied.
- Limit of one (1) gift per eligible customer.

#### 4. Gift Collection

- Gifts must be collected from the Westpac branch where the account was opened, at the time the customer's card is ready for collection, unless otherwise advised by Westpac.

- Westpac reserves the right to substitute the advertised gift with an alternative item of equal or greater value if required.

#### **5. Gift Availability**

- The promotion is limited to available stock.
- Once all gifts have been distributed, the promotion will automatically end, regardless of whether the Promotion Period has concluded.

#### **6. Non-Transferable**

- Gifts are not transferable, exchangeable or redeemable for cash, credit or any other benefit.

#### **7. Card Approval**

- Issuance of a Westpac Visa Debit Card remains subject to Westpac's standard account opening requirements, customer identification procedures and approval criteria.
- Customers who do not successfully complete the account opening process or whose Visa Debit Card application is not approved will not be eligible for the promotional gift.

- Personal information collected in connection with this promotion will be handled in accordance with Westpac's Privacy Policy and applicable privacy laws.
