## **Terms and Conditions**



- 1. Each finalist residing outside of Port Moresby, will receive economy class return airfares, single room accommodation including breakfast and dinner from the date of arrival until date of departure. Westpac PNG will make the travel arrangements individually with each finalist according to their personal circumstances.
- 2. The Westpac Outstanding Woman Awards (WOWA) of the Year Winner may claim up to K5,000 for education-related expenses only over a period of one year as part of the Education Grant prize. Must supply receipts for education-related expense reimbursements that or official invoices for direct payment by Westpac PNG. The grant is non-transferable, cannot be taken as cash and any residual monies at the end of the given period remains the property of Westpac PNG. This grant is only given to the winner and no other persons. Any dispute over what constitutes education-related expenses or invoices will be referred to the Chief Executive of Westpac PNG and payment made at his/her discretion.

The overall WOW Award Winner will receive economy return airfares, hotel accommodation and three meals (or daily stipend) and return transfers to attend one of The Australian Executive Women's Leadership Symposiums in Australia during 2025 or 2026. Other networking opportunities maybe offered at the discretion of Westpac PNG. The date and location will be mutually agreed between Westpac PNG and the Winner.

The Terms and Conditions apply for a term of 12 months from the announcement as a finalist and by submitting a nomination form you accept these Terms and Conditions. All information submitted on the nomination form must be true and correct at the time of nominating.

As nominee, I give permission to Westpac PNG to use my details to promote their products and services. The nominee will attend all presentations and activities they have qualified for as a finalist and be available to assist with promoting the events associated with the WOWA if asked.

If the nominee is the WOWA Winner, she agrees to make time available for promotional appearances during the term of the Awards, abiding by the terms set out below:

- Do not submit original documents to the WOWA as they cannot be returned.
- The WOWA are open only to women who are citizens or permanent residents of PNG and who are 18 years or older.
- Employees of Westpac PNG and previous WOWA Winners are not eligible to enter.
- WOWA Winners must use the full title of their WOWA in any publication or promotion they undertake.
- If at any time during the judging phase a finalist or their business goes into bankruptcy, voluntary administration, receivership, or liquidation the finalist is required to advise the event organisers and accepts that they may no longer be a finalist. In this eventuality the event organisers will put forward the next finalist receiving the highest number of votes in the respective category as the replacement finalist.
